**Guidelines for inclusion, deletion, updation in regard to additional information on qualifications, experience, area of expertise etc .**

1. The List of Resource persons will be updated on every Quarterly basis i.e. in April, July, October and January.
2. Applications received will be scrutinized by IPA and placed before Governing Body for inclusion of fresh applicants in the field of his expertise.
3. Applicants should clearly indicate his Address, emailed, contact no., educational qualifications with year of passing out, details of experience, Organisation-wise by year wise break up, domain knowledge and area of expertise.
4. If any adverse remark is received from the port on a resource person, his name will be deleted from the list after due examination.
5. Any additional information is required to be included in the CV by a resource person it will be added on the quarterly updation.
6. Discretion of inclusion of a resource person, solely lies with IPA.
7. The terms & conditions of engagement of the resource person is in accordance with Guidelines prescribed by IPA's Governing Body.
8. If an applicant wants to withdraw himself from the List of resource persons, he/she should inform in writing or through email.
9. Port will have the discretion to call any of the resource person to be engaged in any area of the CoE.
10. Remuneration level may be reviewed /enhanced by IPA's Governing Body depending upon the market conditions.
